## Iran Sanctions- Extension of Temporary Iran Sanctions Relief through 7 July, 2015

On June 30, 2015, the P5+1 (China, France, Germany, Russia, UK and USA) and Iran decided by mutual consent to extend the Joint Plan of Action (JPOA) for seven days in order to continue negotiations to reach a comprehensive solution. Accordingly, the State and Treasury Departments issued the attached Guidance on the continuation of sanctions relief, and have announced that the sanctions relief provided on 25 November, 2014 are extended through 7 July, 2015.

The categories of relief and the type and extent of sanctions relief provided under the JPOA remain unchanged.

# GUIDANCE ON THE CONTINUATION OF CERTAIN TEMPORARY SANCTIONS RELIEF IMPLEMENTING THE JOINT PLAN OF ACTION, AS EXTENDED

On November 24, 2013, the United States and its partners in the P5 + 1 (China, France, Germany, Russia, the United Kingdom, and the United States, coordinated by the European Union's High Representative) reached an initial understanding with Iran, outlined in a Joint Plan of Action (JPOA).

On June 30, 2015, the P5 + 1, EU, and Iran decided by mutual consent to extend the JPOA for seven days in order to continue negotiations to reach a comprehensive solution. Accordingly, the U.S. Government (USG) hereby extends the JPOA sanctions relief provided on November 25, 2014, as implemented via Guidance, Frequently Asked Questions, and Statement of Licensing Policy, through July 7.

All JPOA sanctions relief described in the Guidance, Frequently Asked Questions, and Statement of Licensing Policy documents of November 25, 2014, which provide relief through the "JPOA Relief Period" ending on June 30, 2015, is now extended through July 7, 2015. The categories of relief and the type and extent of sanctions relief provided under the JPOA remain unchanged from the November 25, 2014 extension of sanctions relief. All activities conducted in accordance with the sanctions relief must be concluded while the relief is in effect.

Effective July 1, 2015, all specific licenses that: (1) were issued pursuant to OFAC's Second Amended Statement of Licensing Policy on Activities Related to the Safety of Iran's Civil Aviation Industry, and (2) have an expiration date of June 30, 2015, are hereby authorized to remain in effect according to their terms through July 7, 2015.
