Announcement by the Ministry of Transport on the Suspension of Special Port Dues for U.S. - Linked Vessels and the Suspension of the Investigation into the Impacts on the Security and Development Interests of the Shipping Industry, Shipbuilding Industry, and Related Industrial and Supply Chains

In implementation of the consensus reached during the 2025 China-U.S. Kuala Lumpur economic and trade consultations, and upon approval by the State Council, from 13:01 on November 10, 2025, in synchronization with the U.S. suspension of the final measures of the Section 301 investigation into China's maritime, logistics, and shipbuilding sectors, the following will be suspended for one year:

The Announcement by the Ministry of Transport on Imposing Special Port Dues for U.S. Vessels (Ministry of Transport Announcement No. 54 of 2025);

The Notice by the General Office of the Ministry of Transport on Issuing the Implementation Measures for Imposing Special Port Fees for U.S. Vessels (JTBS [2025] No. 59);

The Announcement by the Ministry of Transport on Initiating an Investigation into the Impacts on the Security and Development Interests of the Shipping Industry, Shipbuilding Industry, and Related Industrial and Supply Chains (Ministry of Transport Announcement No. 55 of 2025).
